The document will be sent by e-mail.

A single-stage, where two envelope RFP process will be used, and the Proposal will consist of (i) the Technical Part, without any reference to prices; and (ii) the Financial Part, as detailed in the RFP Document. The Technical and Financial Parts of the Proposals shall be submitted simultaneously in two separate sealed envelopes.
7. The Proposal, both the Technical Part and the Financial Part, must be delivered to the address below on 18/03/2025 at 10:30am (local time).. Electronic Procurement will not be permitted. Late Proposals will be rejected. The Technical Part of the Proposals will be publicly opened in the presence of the Proposers' designated representatives and anyone who chooses to attend at the address below on 18/03/2025 at 11:00am (local time). The Financial Part shall remain unopened and will be held in safe custody of the Employer until the second public opening of the Financial Part, following the evaluation of the Technical Part of the Proposals.
8. All Proposals must be accompanied by a "Proposal Security" of 160,000USD or in convertible currency.
9. The non-compulsory site visit is scheduled on 27/03/2025 and the meeting point is Karongi District Office at 11:00am.
10. The pre-bid meeting shall take place on the site at the end of site visit on the same day.
